

GRANTS FOR ARTS PROJECTS

Grants for Arts Projects (GAP) provides expansive funding opportunities to strengthen the nation's arts and cultural ecosystem. Grants are available for arts projects in a wide variety of artistic disciplines. Each discipline has identified the types of projects that are of greatest interest within this program as well as the characteristics of competitive applications.

Applicants may request cost share/matching grants ranging from \$10,000 to \$100,000.

Designated local arts agencies eligible to subgrant may request from \$30,000 to \$150,000 for subgranting programs in the Local Arts Agencies discipline.

A minimum cost share/match equal to the grant amount is required for all grant recipients.



From the typeface on this page to the neighborhood in which you live, every object and place is the result of design. Design surrounds us, influences our experiences, and has a direct impact on the quality of our lives.

The NEA's Design program defines our particular ecosystem as a complex and interdependent set of relationships that start with national and local design organizations, with designers at the center. The organizations range from discipline-specific presenters and conveners, to service organizations, to museums, community design centers, university programs, and educational initiatives that engage youth and adults, as well as other organizations whose work involves design. These groups and individuals are connected to each other based on design discipline; priorities and values; and/or identities, including ethnicity, race, gender, sexual orientation, and disability. Through these connections they build virtual communities that nurture designers and influence the field of

Enabling Legislation for the National Endowment for the Arts in the National Foundation on the Arts and the Humanities Act of 1965

The National Endowment for the Arts (NEA) is proud to support the nation's arts sector with grant opportunities so that together we can help everyone live more artful lives.

"Artful lives" is an inclusive concept encompassing everything from the creation, presentation, and consumption of art, to active arts engagement by all people through making, teaching, and learning in our everyday lives. The arts contribute to our individual well-being, the well-being of our communities, and to our local economies. The arts are crucial to helping us make sense of our circumstances from different perspectives.



Project-Based Support

We support:

- Large and small projects
- Existing and new projects
- Projects that take place in any part of the 50 states, D.C., and U.S. jurisdictions, in communities of any size

Additionally:

- Projects may be for a two-year period of support
- Applications may contain several components, or a single phase of a larger program
- All projects must be both programmatically and physically accessible
- Applications may focus on a particular constituency, but may not be exclusionary under federal antidiscrimination policies

Community-based Projects

- Commissions and production of new design work;
- Design-related exhibitions, festivals, tours, publications, or websites;
- Design projects that foster positive social impact, employ inclusive and/or accessible design concepts, or foster collaboration between design and non-arts disciplines;
- Education, mentorship, apprenticeship, and outreach activities that teach design practices to American communities;
- Community planning, charrettes, and design-related activities;
- Historic and community preservation projects;
- Design and community planning for new arts/cultural buildings, districts, neighborhoods, public spaces, landscapes, or housing for artists or designers;
- Design projects to advance the health and well-being of individuals and communities.








Snow Pond Village | progress concept plan Sidney, Maine



- Projects that advance or sustain the creative work/careers of aspiring designers
- Conferences, symposia, and other gatherings that promote innovation in design practice or design education;
- Workshops or residencies for designers;
- Design research or collaboration projects;
- Projects that reach broader and more diverse groups through digital or emergent technology, including hybrid (in-person and digital) programming activities;
- Design competitions
- Projects that advance or sustain the creative work/careers of people with disabilities

Drawing upon hair transplant research, Kerasynth is a synthetically grown biological material that can replace all keratin-based animal fibers. The speculative project uses a microfluidic "skin" that provides nutrition to animal hair follicles that are implanted on its surface. Designers can fashion the fur-lined skin into living garments or harvest the lab-grown fur.

Since BDC, Kerasynth exhibited at the Gregg Museum of Art & Design and the Esther Klein Gallery in Philadelphia.

- Organizations must have a 3 year history of arts programming
- Individuals
- Fiscal Sponsors
- Commercial/for profit enterprises



Compliance Requirements

Accessibility

All projects must be both programmatically and physically accessible to individuals with disabilities.

Non-discrimination

Applications may focus on a particular group or demographic; however, they <u>may not be exclusionary</u> under Federal civil rights laws and policies prohibiting discrimination. This extends to hiring practices, designer selection processes, and audience engagement.

GRANTS FOR ARTS PROJECTS: How to Apply

Applying for a federal grant can be time consuming. Please be sure to give yourself sufficient time for registration, which can take several weeks. We estimate that after registering, the process to draft and submit an application takes approximately 26 hours.

Submitting an application is a multi-step process:

- 1. **Register** with <u>Login.gov</u> , the System for Award Management (SAM) at <u>SAM</u> .gov, and <u>Grants.gov</u> or renew/verify these registrations. <u>Download Registration Guidance PDF</u>.
- 2. Submit your application:
 - Application Part 1, Grants.gov

Submit to Grants.gov the "Application for Federal Domestic Assistance/Short Organization Form." This is a brief form that will collect basic information about your organization. A direct link to the Grants.gov Opportunity Package is included further down this on this page. You must successfully submit Part 1 in order to continue to Part 2. Part 1: Submit the Application for Federal Domestic Assistance/ Short Organizational Form (SF-424) to Grants.gov

You will use Grants.gov Workspace to complete Part 1 in Grants.gov. For a detailed guide on how to use Workspace, see here.

- Access the application package on the <u>How to Apply</u> page by clicking on the link found under "Direct link to Grants.gov Opportunity Package for Part 1." This will take you directly to the pre-populated application package in Grants.gov. The package for February and the package for July are different, and are typically posted at least one month prior to each deadline.
- 2. The Grants.gov "View Grant Opportunity" screen will open, click the red "Apply" button. If the "Apply" button is grey, it's likely that you are either not logged into grants.gov, or that your account does not have the right participant role. In order to create the Workspace application, you must be logged into Grants.gov with a participant role of either Workspace Manager or Authorized Organization Representative (AOR). Enter information directly into the form. Do not copy from an old Application for Federal Domestic Assistance/Short Organizational Form or another document and paste into the form.

EMAILS: Due to restrictions from the Department of Homeland Security we are not able to send emails to alias addresses that forward to another email account. Do not enter this type of email address.

Part 2: Submit the Grant Application Form through the Applicant Portal

You will only be able to complete Part 2 of the Grants for Arts Projects application process if you have successfully submitted Part 1 of the application to Grants.gov by the appropriate deadline.

You will not have access to the Applicant Portal until the Part 2 application window opens as described in the calendar. However, we urge you to use this document to prepare your responses and material well in advance so you will have them ready to upload once the system opens.

The Applicant Portal is an NEA-administered site. I If you run into technical issues, please reach out to your designated <u>program specialist</u>.

Access the Applicant Portal

Log on to the Applicant Portal at: https://applicantportal.arts.gov

- User Name = Grants.gov Tracking Number (Example: "GRANT38906754")
 - Your Grants.gov tracking number is assigned to you by Grants.gov at the time you submit Part 1 of your application.
 - o A confirmation screen will appear in Grants.gov once your submission is complete.
 - Your Grants.gov tracking number will be provided at the bottom of the screen.
- Password = Agency Tracking Number/NEA Application Number (Example: "1425736")
 - The NEA assigns the number to your application 1-2 business days after you submit Part 1 of your application.
 - The AOR may retrieve the number by following these steps:
 - Log on to Grants.gov.
 - Under Grant Applications, select Check Application Status.
 - Look for your Grants.gov Tracking Number and select Details under the Actions column.
 - You'll be taken to the Submission Details screen to find your Agency Tracking#/NEA Application Number.
 - NOTE: Check Application Status is a separate feature from Track My Application at Grants.gov.

The User Name and Password can only be used by one person at a time in the Applicant Portal. If multiple people use the User Name and Password at the same time to work on an application, data will be lost.

 The Applicant Portal is best viewed in the following browsers: Chrome 58+, Firefox 54+, or Microsoft Edge 44+. You should only open the Applicant Portal in one browser at a time to enter information. Cookies and JavaScript may need to be enabled for you to

Design Particulars/FAQs

How should I think about the budget?

1:1 match, costs = at least 2x the requested amount (think of it as showing your "half" and NEA's "half")

Costs should align with narrative and scheduled activities

What amount should I request?

Allowable amount is \$10,000-\$100,000; Design average amount is ~\$30,000

How likely is my project to be funded?

Design awards ~50% of applications each year



Design Particulars/FAQs

What else is important to think about?

Work Samples! They add color, texture, character to an otherwise all-text document

The ART of Design

WHO (Who will benefit)
WHAT (What are the activities)
WHY (Why this project, why now, why federal funding)
