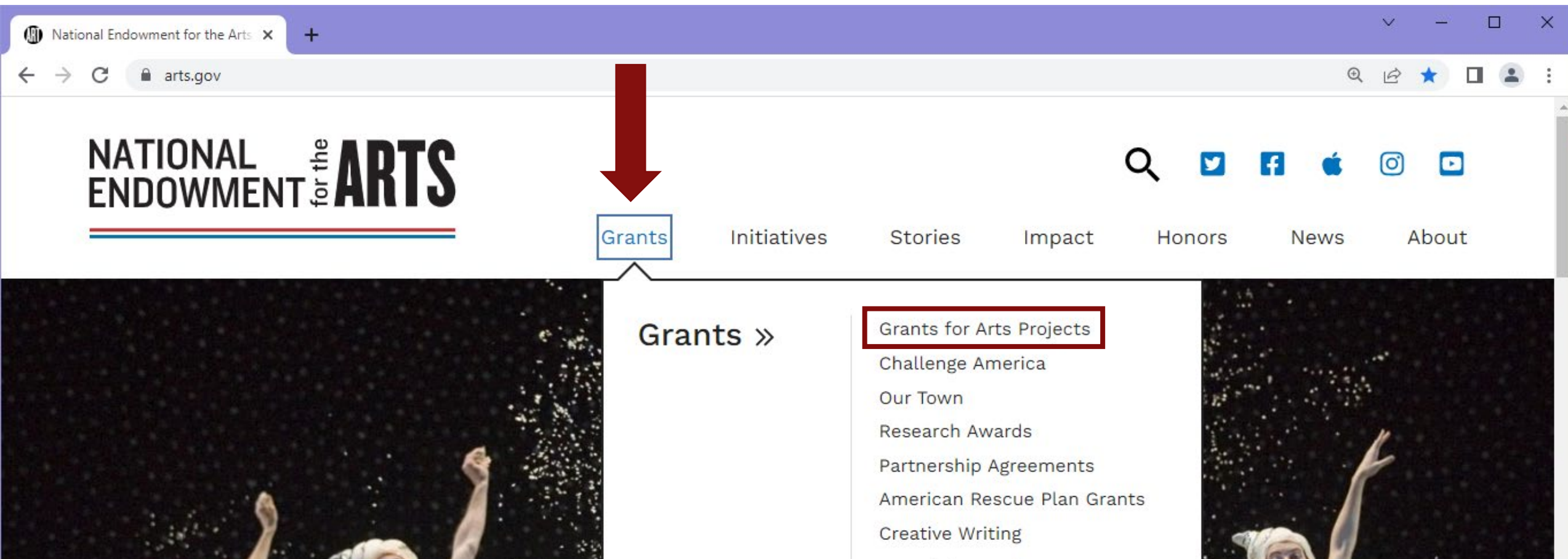

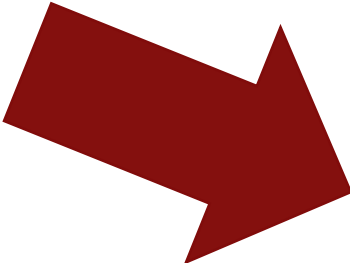

## GRANTS FOR ARTS PROJECTS: How to Apply

Submitting an application is a multi-step process:

- **Register** with [Login.gov](#), System for Award Management (SAM) at [Sam.gov](#), and [Grants.gov](#) or renew/verify these registrations.
- **Part 1:** Submit to Grants.gov the “Application for Federal Domestic Assistance/Short Organization Form.” This is a brief form that will collect very basic information about your organization. A direct link to the Grants.gov Opportunity Package is included further down this on this page.
- **Part 2:** Complete the “Grant Application Form (GAF)” and upload items through the NEA’s Applicant Portal. This web form is where you will enter the majority of your application material (e.g., project description, timelines, budget information).

Login.gov, SAM, Grants.gov (Part 1), and the NEA’s Applicant Portal (Part 2) are all separate online systems.

# How to Apply

## Application Instructions:

For instructions on completing Part 1 and Part 2, select the artistic discipline that most closely corresponds with your proposed project activities. Instructions and requirements vary between disciplines.

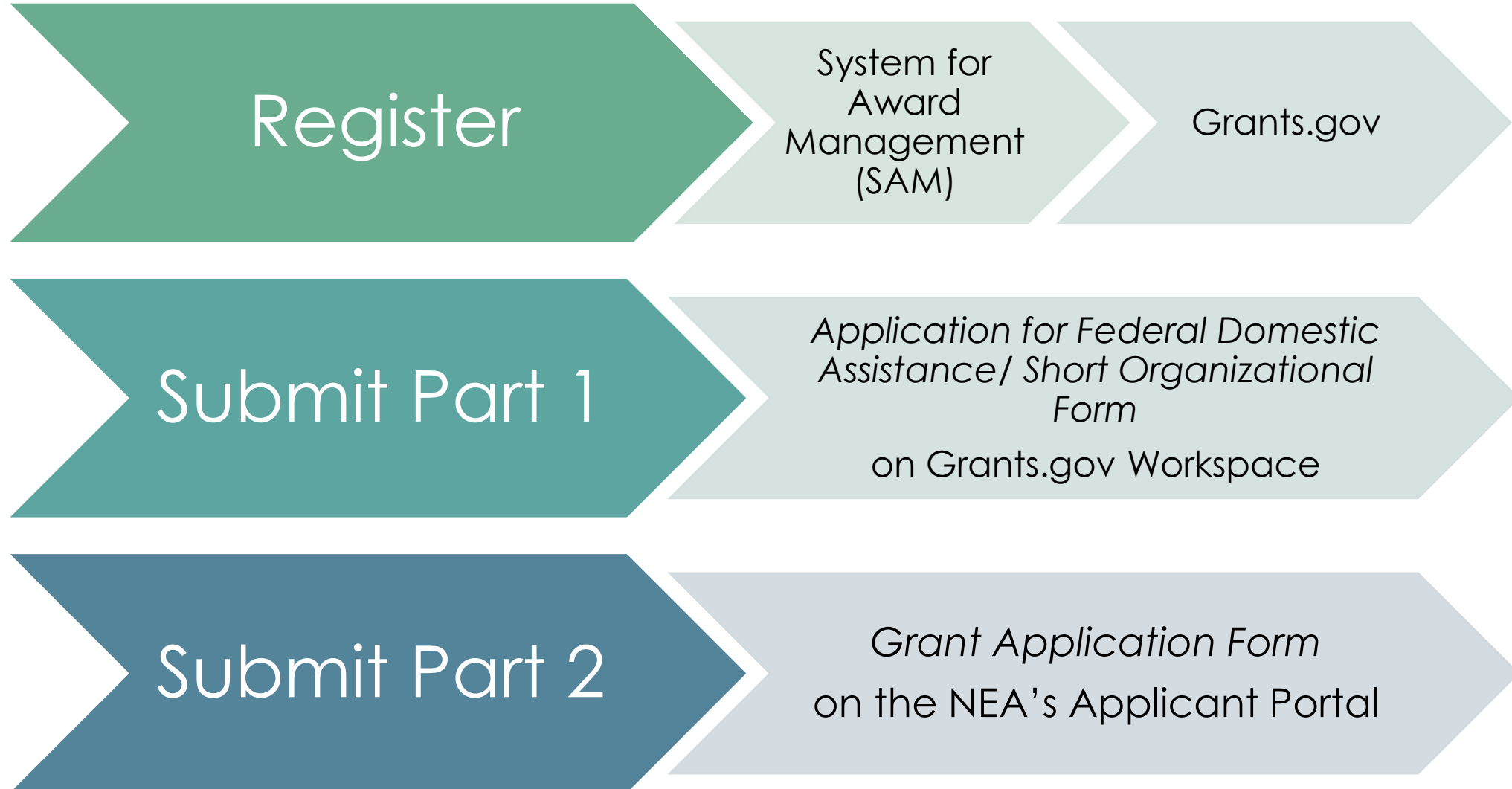

# Application Review: Criteria

## Artistic Excellence

The quality of the artists and other key individuals, creative process, works of art, organizations, arts education providers, artistic partners, and/or services involved in the project and their relevance to the audience or communities the project aims to serve.

# Application Review: Criteria

## Artistic Merit

The value and appropriateness of the project to the organization's mission, artistic field, artists, audience, community, and/or constituency.

The ability to carry out the project based on such factors as:

- appropriateness of the budget
- clarity of the project activities, resources involved, and
- qualifications of the project's personnel and/or partnerships.

Clearly defined goals and/or proposed outcomes, and an appropriate plan to determine if those goals and/or outcomes are met. This includes, where relevant, measures to assess student and/or teacher learning in arts education.

Evidence of direct compensation to artists, art collectives, and/or art workers.

### **As applicable:**

- Engagement with individuals whose opportunities to experience the arts are limited by geography, race or ethnicity, economics, or disability.
- Ability to strengthen the arts sector through knowledge-sharing and resources

# Compliance Requirements

## Accessibility

All projects must be both programmatically and physically accessible to individuals with disabilities.

## Non-discrimination

Applications may focus on a particular group or demographic; however, they may not be exclusionary under Federal civil rights laws and policies prohibiting discrimination. This extends to hiring practices, artist selection processes, and audience engagement.

## National Historic Preservation Act & National Environmental Protection Act

# Dance GAP Guidelines

Dance is a vital expression of culture and possesses the ability to create community, cultivate space for reflection and dialogue, and bring awareness to social issues through a spectrum of genres and practices.

Can support organizations including companies, presenters, service organizations, educators, festivals, and more

Dance companies may be artist-led, collaborative, and include disabled and non-disabled artists.

Projects may be of any size and at any stage of the process including planning, creation, implementation, and may focus on providing services that strengthen the dance field's capacity through knowledge-sharing and resources.

# Dance Project Objectives:

**We encourage projects that further one of these objectives:**

- Are led by and/or engage disabled artists and practitioners in pursuit of artistic and creative goals rather than therapeutic outcomes.
- Provide opportunities for artists to research, create, or share artistic practices and works, or access significant professional development programs essential for career advancement.
- Document and preserve choreography, performances, and other aspects of dance history in ways that increase the diversity of artists, forms, and cultures in existing archives using archival practices that demonstrate cultural integrity.
- Represent dance forms, techniques, and histories that stem from all over the world.
- If applicable, offer direct payment to artists as part of the project.

# Competitive Dance Projects:

- Demonstrate alignment with the NEA's commitment to diversity, equity, inclusion, and accessibility.
- Make a significant impact within local or regional communities and/or the dance field.

- Involve reciprocal partnerships that advance the goals of the project
- When applicable, clearly describe how artists/companies are selected and how those artists/companies are diverse, including in relation to audiences and communities the project will engage.

# New & Revised Application Questions

## **ORGANIZATIONAL CONTEXT FOR PROJECT ACTIVITIES**

Describe your organization's history and operations, including the context in which your organization will undertake the project activities.

## **PROJECT SYNOPSIS**

Provide a brief synopsis for your proposed arts project.

## **PROJECT DESCRIPTION**

Describe the project activities that will take place during the period of performance, and provide information on curatorial/selection process, artists, creative process, works of art, productions, venues, public or community engagement activities etc.

# New & Revised Application Questions

## **ENGAGEMENT WITH INTENDED COMMUNITY, PARTICIPANTS, & AUDIENCE**

Describe the intended communities, participants, or audiences involved in the project activities, and how they will benefit. Clearly explain how you will engage these groups. Where applicable, include how you will involve and accommodate people with disabilities in the planning, creation, and/or implementation of your project activities.

## **PROJECT GOALS AND MONITORING**

What are your goals for this project? What do you hope you and/or those involved will learn or experience? Describe how you will monitor progress toward your project goals. Examples of monitoring activities include surveys of program participants, measuring attendance, and third-party program evaluations, among others.

# New & Revised Application Questions

## **OTHER PROJECT INFORMATION (optional)**

If there is anything else that would be essential for panelists to understand about your project relative to the review criteria, provide it here.

## **PROJECT PARTNERS & KEY INDIVIDUALS**

Outline up to ten key individuals (such as staff, artists, teaching artists, collaborators, consultants, mentors) and/or partner organizations involved. Because all projects require matching resources from non-federal sources, organizations that only provide money are not considered partners.

## **INDIVIDUAL BIO/ PARTNER DESCRIPTION**

Describe why you have chosen the individual or partner for this project, what their role will be, and their biographical experience or knowledge relative to this project.

# Eligible Project Types for Dance

Examples of eligible project types are offered below to demonstrate a range of possibilities. Your project may fall within multiple areas listed below. Project activities may take place virtually, in person, or in a hybrid format.

- Creation, development, or restaging of works
- Presentation and touring
- Preservation, documentation, and archiving
- Professional development and services to the field
- Education and community engagement projects

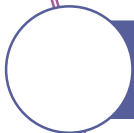
# Tips



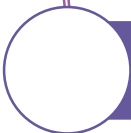
Don't assume the panel is familiar with your organization.



Make sure your project budget, narrative, and work samples tell the same story.



Be as clear and specific as you can.



Be clear about artists and company fees in your budget.



Request panelist feedback within 30 days of your application notification.

Start early!



# Work Sample Tips

- 1 Work Samples should add an additional layer of understanding to your project.
- 2 Panelists will spend a maximum of 20 minutes with your work samples.
- 3 Submit relevant and recent video samples.
- 4 Avoid promo videos, montages, or highly edited videos.
- 5 Include captioning.
- 6 Use the Dance Guidelines to prepare your work samples.
- 7 Put all video sample links in one PDF (include passwords, if applicable)
