



Agencies Receiving More than 50 Requests in FY16

INTRODUCTION

The National Endowment for the Arts (NEA) is a small agency with approximately 160 staff members and no agency components. The agency's day-to-day FOIA operations are proportionately small. One FOIA Officer processes all of the NEA's FOIA requests. The FOIA Officer is supervised by the NEA General Counsel/Chief FOIA Officer, India Pinkney. The NEA is committed to making its work more transparent and recognizes that FOIA is a fundamental element of Open Government. By applying a presumption of openness and maintaining effective FOIA operations, the agency seeks to expand the availability of its information to the public. The following report describes the steps taken by the NEA to implement the Freedom of Information Act during the past year.

A. FOIA Training

Answer: The primary FOIA professional and the FOIA Public Liaison attend various trainings offered by DOJ such as *FOIA for Attorneys and Access Professionals, FOIA Litigation Seminar, Continuing FOIA Education and the Report Refresher Trainings.*

Answer: 85% of the FOIA professionals attended substantive FOIA training. However remaining Office of General Counsel Staff (who don't have FOIA responsibilities) will participate in at least one DOJ sponsored training before next reporting period.

B. Outreach

Answer: Yes, both the FOIA officer and the FOIA Public Liaison participated in the open government group discussions in person and via teleconference.

Answer: Information regarding FOIA responsibilities are provided with the on-boarding of new staff. FOIA professionals are also available for one-on one consultations as needed and to respond to specific FOIA related questions. FOIA modules are in the process of being re uploaded to the agency electronic learning systems due to changes in service provider.

Answer: The presumption of openness is consistently reinforced in Senior Management and Office Heads meetings throughout the agency. Newsletter subscriptions managed by the Office of Public Affairs also provides the public with updated access to information about the agency.
