



Grants for Arts Projects

Grants for Arts Projects (GAP) is the National Endowment for the Arts' largest grants program.

Through project-based funding, the program supports opportunities for:

- Public engagement with the arts and arts education
- the integration of the arts with strategies promoting the health and well-being of people and communities
- the improvement of overall capacity and capabilities within the arts sector



Grants for Arts Projects

The NEA is committed to diversity, equity, inclusion, and accessibility, and fostering mutual respect for the diverse beliefs and values of all individuals and groups. We encourage projects that address any of the following:

- Elevate artists and makers as integral and essential to a healthy and vibrant society.
- Celebrate the nation's creativity and/or cultural heritage.
- Facilitate cross-sector collaborations that center the arts at the intersection of other disciplines, sectors, and industries.
- Advance the health and well-being of individuals and communities.
- Invest in organizational capacity-building and leadership development for arts organizations, arts workers, and artists.
- Support existing and new technology-centered creative practices across all artistic disciplines and forms, as well as build arts organizations' capacity to serve a broad public by providing access, training, and other resources to engage with digital technologies
- Develop creative work exploring or reflecting on the impacts of artificial intelligence (AI), in a way that is consistent with valuing human artistry.



Grants for Arts Projects

- To mark the semiquincentennial of the United States of America in 2026, the NEA also seeks arts projects furthering its mission of fostering and sustaining an environment in which the arts benefit everyone in the United States. The NEA is partnering with America250 to encourage arts projects that educate and engage communities in dialogue about the past, present, and future of our nation. Project examples may include public art recognizing the milestone, collaborative community arts projects exploring the nation's identity, or retrospectives of celebrated or overlooked American artists.
- Support projects originating or are in collaboration with constituencies that include: Tribal Colleges and Universities, American Indian & Alaska Native tribes, and Asian American and Pacific Islander communities.
 These projects are all further encouraged by White House executive orders.

Award Information

- Grants will range from \$10,000 to \$100,000
- All grants require a 1 to 1 nonfederal cost share/match
- Cost share may be any combination of cash and/or in-kind, third-party contributions
 - Federal funds may not be used as part of the cost share/match

Grants for Arts Projects: Dance FY25 Application Instructions

Introduction and Calendar

A Grants for Arts Projects (GAP) application consists of two parts:

Part 1: Submit the Application for Federal Domestic Assistance/Short Organizational Form to Grants.gov. This form collects basic information about your organization. You must successfully complete Part 1 in order to have access to Part 2.

Part 2: Submit the *Grant Application Form (GAF)* through the NEA's Applicant Portal (AP). The GAF collects the remainder of your application, including:

- Answers to narrative questions about your organization and project,
- Budget information about your organization and project,
- · Information about key individuals and partners, and
- Work samples.

This document will walk you through how to submit both parts of the application.

Be sure that you have selected the discipline that corresponds to your project (e.g., Arts Education, Dance, Music, Visual Arts, etc.) as application instructions and requirements vary between disciplines.

Submission Deadlines:

All deadline times are Eastern. Be sure to double check the deadline time based on your time zone.



Application Review: Artistic Excellence Criteria

Artistic Excellence

The quality of the artists and other key individuals, creative process, works of art, organizations, arts education providers, artistic partners, and/or services involved in the project and their relevance to the audience or communities the project aims to serve.



Application Review: Artistic Merit Criteria

Artistic Merit

The value and appropriateness of the project to the organization's mission, artistic field, artists, audience, community, and/or constituency.

The ability to carry out the project based on such factors as:

- appropriateness of the budget
- clarity of the project activities, resources involved, and
- qualifications of the project's personnel and/or partnerships.

Clearly defined goals and/or proposed outcomes, and an appropriate plan to determine if those goals and/or outcomes are met. This includes, where relevant, measures to assess student and/or teacher learning in arts education.

Evidence of direct compensation to artists, makers, art collectives, and/or art workers.

As applicable:

- Engagement with individuals whose opportunities to experience the arts are limited by geography, race or ethnicity, economics, or disability.
- Ability to strengthen the arts sector through knowledge-sharing and resources

Panel Review Insights

Competitive projects will:

- Respond to Artistic Excellence and Artistic Merit Review Criteria
- Demonstrate alignment with the National Endowment for the Arts' commitment to diversity, equity, and inclusion
- Steer clear of jargon
- Describe clear goals and ways of measuring those goals



Challenge America offers support primarily to small organizations for projects in all artistic disciplines that extend the reach of the arts to populations that are underserved.

- Entry point for organizations seeking NEA funding
- Abbreviated application
- Robust structure of technical assistance
- Grants a set amount of \$10,000
- Requires cost share/match of \$10,000



"<u>Underserved</u>," as defined by our legislation and agency policy refers to:

 Those whose opportunities to experience the arts are limited by geography, ethnicity, economics, or disability.



Eligibility:

- First-time applicants to the NEA are eligible.
- Previous Challenge America grantees are eligible.
- Previous NEA applicants that were not recommended for funding under any other NEA grant programs in any of the three most recent Fiscal Years are eligible.
- CARES Act / ARP Act grantees are eligible.
- NEA grantees in grant programs other than Challenge America from the three most recent Fiscal Years are NOT eligible.

Helpful Hints

- Start early and give yourself plenty of time.
- Ensure that you have successfully completed your Grants.gov and Sam.gov registrations.
- Use Grant Search on arts.gov to research previously awarded grants.
- Request panel feedback on your application in the future, whether or not you receive an award.



Helpful Hints

- Don't assume the reviewers are familiar with your organization or your work.
- Choose a project that exemplifies what you do best.
- Be as specific as possible.
- List artists & partners under consideration if not yet confirmed.
- Make sure your budget and project narrative tell the same story.
- Serve as a panelist!



Work Sample Tips

- Review the work sample instructions prior to submission.
- Choose work samples that support the project in your narrative and project budget.
- Recent samples should be included.
- If applicable, include samples by artists involved in the project.
- Don't overwhelm the panelists with too many work samples as panelists' review time is limited.
- Detail exactly what you want the panel to review
- Contact us if you have questions!




Plan of Action for Tribal Consultation

In response to President Biden's January 26, 2021 Memorandum on Tribal Consultation and Strengthening Nation-to-Nation Relationships of, the National Endowment for the Arts is pleased to share its Tribal Consultation Policy. The policy is in keeping with the NEA draft Plan of Action for Tribal Consultation, which was informed by a tribal consultation call on April 7, 2021, and was informed by ongoing agency engagement with Native artists, organizations, and cultural leaders. A draft consultation policy was formally reviewed in consultation with tribal leaders on August 10, 2021 (summary). October 25, 2023 Consultation

On October 25, 2023, the NEA held a <u>tribal consultation</u> to gather input from tribal leaders on the needs and concerns of tribal communities as related to NEA resources and grants, to provide an update on NEA's engagement with Native cultural leaders and tribal-serving organizations, and to inform our work related to the Executive Order on Advancing Racial Equity and Support for Underserved Communities Through the Federal Government. A <u>summary of the consultation</u> is now available.
