

## National Endowment for the Arts Requirements for Acknowledgement of NEA Support

Partnership Awards

## 1. Requirements for State Arts Agencies (SAAs) and Regional Arts Organizations (RAOs).

SAAs and RAOs must clearly acknowledge support from the National Endowment for the Arts in their programs and related promotional materials for the life of the grant period.

The following examples are included as models for **print/Web** acknowledgement. They may be utilized as is or segments from more than one example may be combined as appropriate for your agency's circumstances:

- This project is supported in part by an award from the National Endowment for the Arts.
- Funding for the \_\_\_\_\_ Arts Commission and its programs is provided by the State of \_\_\_\_\_ and the National Endowment for the Arts, a federal agency.
- The \_\_\_\_\_ Arts Commission is funded by the \_\_\_\_\_ State Legislature, other public and private sources, and the National Endowment for the Arts.

In addition, SAAs and RAOs are encouraged to incorporate the current NEA logo into their agency's publications and Web site along with the acknowledgement of NEA support. For **radio or television broadcast**, we require the following language: *"This project is supported in part by an award from the National Endowment for the Arts."* For television broadcast, display of the current NEA logo is required.

## 2. Requirements for All Organizations Receiving Awards from State and Regional Agencies.

SAAs and RAOs should do all they can to make sure their grantees recognize the role of the NEA in the programs that were assisted by NEA support. This will help promote a more complete understanding of the federal role in supporting the arts in each state and region.

In order to prevent inappropriate crediting, SAAs and RAOs should clarify for their grantees that

- NEA crediting language should specify the supported program/activity, and that
- they <u>must</u> remove NEA acknowledgements from their Web sites and printed materials at the completion of their respective grant periods.

The following examples are included as models for **print/Web** acknowledgement. They may be utilized as is or segments from each may be combined as appropriate for your agency's circumstances:

• This project was supported [in part] by the \_\_\_\_\_\_ Arts Commission, which receives support from the State of \_\_\_\_\_\_ and the National Endowment for the Arts.

• This project was supported [in part] by the \_\_\_\_\_ Arts Commission, which receives support from the National Endowment for the Arts, a federal agency.

In addition, recipients of SAA and RAO grants may display the current NEA logo <u>www.arts.gov/manageaward/index.html</u> with the crediting language (as noted above) for the life of the grant period only.

For radio or television broadcast, we require the language noted above in Section 1.
